Communications from Mayor:

Report from Jason Rushing, Director UTM Parsons Center

Mr. Rushing stated that the Parsons Center being offering classes in Spring 2007, Located into the permanent facility January 2009, and as of fall 2010—76 classes 4-degree programs –35 graduate with a BS degree. They have began partnership with TTC Jackson to offer the LPN program (3 years, by sponsorship only.) He also did a power point presentation explaining goals, and growth for each year. Actual count has well gone over the goal that was set. Scholarship program was explained. It will be set up in a special account thru the PDCHEF(Parsons Decatur County Education Foundation Scholarship Fund). It will target adult students (out of High School-- 3 years or more) or GED. There is a greater financial responsibility for this age group (19-35). This age group usually has fewer financial aid opportunities. He also stated that they must reside in Decatur County, and complete a FAFSA Form. Award will apply to fall and spring semesters. Once enrolled students must take a least one course at the Parsons Center consecutively each fall/spring to maintain eligibility. Proposed scholarships to be awarded in a set amount on the following; \$250 per students taking 6 or fewer hours, \$500.00 for students taking 2 or more hours. Scholarships to be tracked by UT Martin Parsons staff and invoiced on a semester basis.
