Old Business:

I: Second Reading on Ordinance No: 250 An Ordinance to Amend the Parsons Municipal Zoning Ordinance: Allowing Homes for the Aged as a use permitted on Appeal in R-1(Low Density Residential and R-2 (Medium Density Residential) Districts - Motion by Dwight Lancaster to pass this Ordinance on second reading . Second by Mark Davis

Discussion - Cecil McNatt, from Lexington, Tennessee, addressed the Council and explained his proposal for land located on Georgia Ave South across from the Decatur County Senior Center. According to McNatt, his assisted living facility will have 25 individual units and will also have an adult day care center to accommodate eight more people. In the adult day care, McNatt said adults can stay a minimum of three hours a day or no more than 23 hours a day and have access to the same care as permanent residents. All other residents who reside there permanently will have 24 hour care including meals, laundry, rooms cleaned and all meals prepared. The building is about a two million dollar investment and will create 17 jobs. McNatt stated it will be about half the price of a monthly nursing home stay for residents - \$2550 compared to about \$5,200. The residents still have flexibility. There will be a registered nurse and doctor on-call to serve the facility 24 hours a day. Rooms will be a home-type setting in the facility. Some rooms have a den, kitchenette with microwave and a separate sleeping area. The process will take about three months to get all the details approved, and they are ready now to start ground construction.
