Communications from Mayor:

Mayor stated that with the Council's ok; he would like to talk to Decaturville's Mayor and Council to outline a multifaceted plan to improve working conditions with the City of Decaturville. The time has passed when we can let politics divide us. I have a good relationship with Mayor Grace; our councils and our recorders work together well. I believe it has become a red herring to say we can't get along, and we owe it to the taxpayers to seize this opportunity to open real dialogue. We can work together to come up with some win -win situations. The Plan, named The Municipal Cooperation Initiative, will include several items that will benefit both cities, ranging from mutual aid agreements, police, and fire assistance, and the coordination of festivals and parades. Another benefit of the program would be the ability to supply Decaturville with water at cheaper rates. It has taken us three years to get our house in order. Our water system has drastically improved, and the installation of two additional intake pumps we have become more efficient and can increase volume. This way we can help the taxpayers of both Parsons and Decaturville save on rates. The Council agreed unanimously to support this measure.

Municipal Building update: Biggest part of the carpet is done. Curves will be in tomorrow; than paving will start in a couple of days. Landscaping will be begin. We should be able to have our next board meeting at the Municipal building since the Christmas Parade will cause our next meeting be on December 12, 2005.

Survey for the Downtown Enhancement Grant has been done. Next phase should start soon. We will have more community input meetings later in the spring.

Raw water line update: Featherfoot easement has been taken care up. Line has been run from water plant to Featherfoot, and all the way down the old railroad bed. Water line will be all the way to the intake soon. They are waiting for the pumps to come in. This will triple the capacity; Filters and basin should be big enough to handle this.

Deed to Kaddis property has been properly executed and recorded.

Mayor Boaz has talked to the City's State Planner to do a feasibility study on existing airport and the City Hall building.
