Communications from Mayor: We have had a busy day today. We have been meeting at UT Martin with the board out there. Branson Townsend, Special Project Co-Coordinator has been working on the Heritage Part of the Peavine Festival coming up September 30th and Oct 1st.

Branson Townsend gave a few more details on Heritage Festival. On October 1st the agenda is building. We do have some interesting speakers coming. They will be at the exhibits Museum and Lobby We have Dr. Lonnie Maness, retired history teacher at UT. Martin,

He is going to be talking about Nathan Bedford Forest. He wrote two books on Forrest's movements in West Tennessee during the Civil War. Phillips Jones, teaches a history class here at UT Martin. He will be here with some of his students who are doing research on some of the soldiers and their families around here during the Civil War. We also have a direct descendant of Private Sam Watkins who was a member of the Tennessee Third Calvary. Many of the soldiers in Decatur fought in the same battles the he was in. He wrote a book call "Company "Aytch" about 20 years after the Civil War. His great-great-granddaughter has up-dated that book, and she is going to be here to do a book signing, and talk about some of the things he has said. We are also going to have a dedication of the Civil Wars Marker Trails Marker beside the parking lot next to the new Memorial Park that will be officially dedicated. Retired Adjudant General Dan Woods along with the Mayor will lead this Park dedication. The Parkers Cross Road Association will be here to do a living history demonstration. We have a lot of things planned for Saturday, October 1' both inside and outside the Municipal Building. A General Grant re-enactor will be here to participate in a panel discussion with the other speakers. We have some exiting events planned. The theme is 'Divided Loyalties".
