Regular Board Meeting, December 5, 2011

The Parsons City Council met for its regular monthly meeting, Monday, December 5, 2011 at 6:00 p.m. at the City meeting room. Mayor Tim David Boaz called the meeting to order.

Community Forum:

Bill Goodman brother of Ms. Annie Haggard, came before Board, and stated that she had problems with sewer when it rained at her rent house. Mayor asked if he had talked to Lee Villaflor, Utility Supervisor. Mr. Goodman stated that he talked to someone, but did not know who he was.

Mayor stated that Lee takes care of this type of situation. We need him here, because he would know about the issue. Is this in reference to the sewer back up at the house on Bible Hill Road below the creek? They stated that it was. Mayor stated that we have had back up at the Cardinal Software office at Tennessee Ave South during the heavy rain, and the City got Jackson Energy Association to come down and clean the sewer lines on Bible Hill and discovered that someone had filled the manhole with rock. When they fixed the bridge at Bible Hill that they found some lines messed up, and fixed that. Mayor stated that these low line houses would be having trouble during heavy rains, and will have, until we get a sewer rehab grant to fix some of the lines. We have tried four years to get one, and have not been successful as of yet. City Recorder will contact Ms. Annie in the morning, and get her with Lee Villaflor to show him where the water is getting in the sewer lines.

Mayor Boaz then asked Branson Townsend to give an update on the new Civil War Exhibit in the Community Room. Mr. Townsend stated that the official public opening was on November 30, 2011 with several visitors. The Tennessee State Museum offers these traveling exhibits regularly. This is the 150th Anniversary of the Civil War and this is the official Tennessee Sesquicentennial commemoration exhibit organized by the state museum. We have our own exhibit, but it is focused on the local community. This exhibit is focused on the State. It stays another couple of months, and moves to another location. It started in East Tennessee, and we are the second museum to get it, and from here it will go to Covington near Memphis. It is a huge compliment to have the exhibit here in Decatur County, and

we look forward to promoting it some more,. Hopefully we will have more people to come by and see it. There is a fee of two dollars to tour this exhibit along with our own exhibits to help with costs, and we have raised monies thru our friends of the Museum at our pre-opening ceremonies. We had a "reading" of local Civil War letters directed by Shane Bridges and featuring the Rivertime Players along with City employees. Museum friend, Jim Burke, dressed as Johnny Reb, also presented a talk on Civil War soldier life. We had a good fund raiser. There is another civil war exhibit the state has promised which will be coming next September. It is more about the Calvary, "Hoof beats in the Heartland". We also are hopeful that we will get a Smithsonian Exhibit from National Smithsonian Traveling Museum during our Centennial in 2013.

Shane Bridges, Digital Factory Director, stated that we have just finished with a class that started with ten applicants and ended with six due to not qualifying because of required credit checks. The six have been doing well with "Live Ops." and are currently going thru credit and background checks. We hope to start a new class after the 1st of the year. We are getting one or two applications a week. We need to spread the word.
