II: First Reading on Ordinance No: 374 Entitled An Ordinance authorizing and providing for the financing of the construction of a water facilities project, including authorizing the execution of applications, contractual agreements, and other necessary documents, and making certain representations, certifications, and pledges of certain revenue in connection with such financing.

This first reading of this Ordinance was to apply for a \$1,809,830 loan from the Tennessee Drinking Water Revolving Loan Fund in order to construct a 500,000 gallon clear well. Mayor Boaz stated that the total cost of the project will be \$3,250,000. The city will use \$1,450,000 in water system reserve monies. The interest rate for the loan will be approximately 1%. Mayor also stated that this project would not require an increase in customer water rates. He further stated that if the City completed the application process by October 1st the revolving water fund would forgive 25% of the principal of the loan.
