Presentations/Communications from the Mayor:

The City of Parsons Fire Department responded to a devastating fire emergency in Decaturville, on January 1, 2023 that was caused by an arsonist, leaving three buildings in total ruins (The Diner, Larry's Exxon and private residence, 123 East White Oak St). City of Parsons has an automatic aid agreement with the Town of Decaturville, and fulfilled the agreement by responding to this fire. We sent one fire truck (Engine 3) with a total of 10 COP firefighters responded to the scene. Once on scene, we were sent to 123 East White Oak St, Decaturville, the 3rd building set on fire, to extinguish the fire and maintain scene integrity as TBI was in charge of the fire investigation.

The Mayor and Wes will sign a new automatic aid with Tim Grace, current Decaturville Mayor and Jeremy Inman, Decaturville Fire Chief to make this agreement current. The original resolution was passed in 2009 establishing the Automatic Aid agreements between the City of Parsons and Town of Decaturville.
