# .PUBLIC HEARING and REGULAR BOARD MEETING OF PARSONS CITY COUNCIL February 6, 2023

The Mayor opened the Public Hearing at 5:45PM Monday, February 6, 2023 for the proposed rezoning of property on Earl Jordan Lane (Teresa Rankin) from B-1 (General Business) to R-1 (Low Density Residential). Ms Rankin purchased this property and didn't know that her property was split residential and commercial. At one time, this particular parcel was zoned to commercial due to a shop running a business out of it. The shop burned down a few years ago, and is no longer there. Seeing no public input, Mayor Boaz closed public hearing.

Kevin Cagle made motion to approve financial statements for <u>December 2022</u>. Second by Dale Reynolds. Motion Carried. Vote: All Ayes. Motion passed unanimously.

# Reports from communities, councilmen, and other officers:

Wes Woodward, Parsons Public Safety Director introduced Parsons Police Department officers to the City Council. Current Parsons Police officers: Chief Wes Woodward, Captain Kyan King, Lt/Inv. Adam England, Inv. Jacob Eaton and Patrolmen Hueston Smith and Mickey Howe. Patrolman-in-training Jordan Parrish.

All Police officers will be sent to 64-hour FF3 and 8 hour live burn class to become PSO (Public Safety Officers) for the fire department.

# Presentations/Communications from the Mayor:

Mayor Boaz and City Administrator Lee Villaflor gave an update to the Liquor Ordinance that will be next on the agenda to be voted on. Final reading will be tonight. Once passed, the City will post a public notice that will announce the acceptance of Applications for a Certificate of Compliance to own a liquor store. This does not guarantee receiving a license. They will still need to be approved by ABC and then be selected into a lottery if there are more than the approved allowed licenses issued.

Lee Villaflor gave update on proposed Verizon Tower. He was contacted by Verizon. They want to put a "monopole" tower on the Parsons Water Tank in town. They are in early discussions and will present to the Council meeting in March 2023.

Discussion ensued. Motion by Dale Reynolds to appoint Mayor Boaz's recommendations to the Industrial Board. Second by Madison Cagle. Motion Carried. Vote: All Ayes (absent and not voting – Marty Carrington). Motion Passed unanimously.
