<u>Project Update</u> - Lee Villaflor, City Administrator

- CDBG Grant Anticipated ETA date for generator is July 14, 2023. No update on transfer switch, but hopeful it will be included in generator arrival.
- TDEC/ARP Contract has been signed between TDEC and City of Parsons
- Sewer ARP Project has been approved. This project will divert wastewater that runs under Parsons
 Elementary School, that line will be capped and rerouted up West Fourth St and install a new lift
 station.

Police/Fire Department Update

- City of Parsons has obtained 4 SCBA's on loan from Decatur County Fire Department for the next year.
- Parsons Police Department has 2 new certified PSO's (Public Safety Officers)
 - o They have completed 64 hours firefighting basic training and 16 hours live burn exercises
 - Public Safety Officers count 2:1 ISO ratio compared to 3:1 Volunteer Firemen ISO ratio
