Nick Wall from Minors Towing and Recovery (Lexington, TN) approached the Mayor and City Council requesting permission to purchase a city owned property located on McCorkle Lane. This company currently serves Parsons and Decatur County and has been for the past year. Minors Towing wants to expand their business and open a location in the city limits of Parsons. They want to build an office building and shop. They would build as required by the State of Tennessee to get on the State Rotation for towing and recovery.

Benefits of bringing this business into the City Limits: Sales tax to the City of Parsons and additional jobs.

Car Sales, Car Storage and Manual Labor = Taxable

Towing = Not Taxable

Timeframe: dirt work still needs to be done, weather permitting, to clear the land. Nick Wall can do his own land clearing. The City Council will discuss this request and get back in touch with Nick Wall.
