PUBLIC INPUT:

Chase and Katie Vise addressed the council during Public Input

- The currently run a gymnastics studio out of First Baptist Church youth room
- They have outgrown where they are at, and will need more space to expand their business
- They have been looking at properties to purchase and found one that would work for their needs
 - City of Parsons owned property located on Georgia Ave, South

Upon recommendation from the city attorney, the city council can entertain an offer to sell this property and pass/approve this purchase with an ordinance with two readings and public hearing before final vote. Chase and Katie Vise will present a written offer to purchase this property before the next council meeting.

REPORTS FROM COMMITTEES, COUNCILMEN, AND OTHER OFFICERS

A) COMMUNICATIONS FROM THE MAYOR:

- a. The City of Parsons will be looking at advertising to have the timber cut at the Sanders Property, the new annexed property.
 - i. The city will need to decide on the specs to place in the bid request
 - 1. Will the city request: clear cut, clean up, level ground, stumps, tops, bare ground?
 - ii. The property is 31 acres, with about 10 acres needing clearing
 - iii. The city will look at similar bid requirements to mirror to decide on specs, and city attorney will review before publishing the public notice.
- B) **PROJECT UPDATES:** Lee Villaflor gave an update on the current projects. TLM sent the most recent progress report and all council members received a copy prior to this meeting.
 - a. <u>ARP Sewer Project (Pipe Bursting)</u>: Construction is in progress and is currently estimated to be 70% completed. The construction company anticipates to be done within the next 45 days.
 - b. <u>ARP Water Plant Project (Drinking water)</u>: We have run into change orders and lines that aren't there, but it looks like everything is settled and we should be able to start construction soon.
 - c. <u>TAM (Tennessee Association of Museums Grant (Municipal Building Roof Replacement)</u>: Roof construction has begun and in process of installing the new roof.
 - d. <u>TDOT (Multimodal Grant)</u>: per TLM, TDOT has not rejected drawings at preliminary (curb design, curb omissions at certain businesses), and foresees no issues moving forward based on no rejections to the submitted designs. TDOT now has ROW plans in review and will follow up.

- e. <u>2024 CDBG (Passive Park)</u>: TLM sent us new schematics from the architect and will schedule a meeting soon to talk with architects and engineers. Environmental phase should be completed in June, then the bid process can start (projecting October or November).
- f. PHMSA Gas Grant: No new update
- g. <u>SRF 4th St Lift Station</u>: SRF responded with "No significant finding impact". Per engineer that is a good response that means there will not be any environmental impact for this project.
- h. FEMA (2019 Hazardous Mitigation) Generator Grant: No new updates.
- i. <u>USDA Truck grant</u>: No new updates.
